4	26/07/2024	Result of English Shorthand Test and Marathi Shorthand Test.
5	28/07/2024	Marathi Typing Test and result followed by English Typing Test on the same day from 10.00 a.m. onward till completion. (Reporting time of candidates 9.00 a.m.)
6	29/07/2024	Result of English Typing Test.
7	31/07/2024 to 01/08/2024	Interview (Time and roll numberwise instructions will be given at the time of result of English Typing Test)

NOTE :-

- (a) The candidates (whose submission and verification process have been completed during the period from 15/05/2024 to 21/05/2024 as per the instructions given in the notice dated 09.05.2024) shall visit District Court, Sangli during the period from 16/07/2024 to 22/07/2024 along with duly verified Admit Card already downloaded by them to rectify the earlier given exam dates and get the new exam dates on the Admit Card which is already verified and returned by District Court, Sangli.
- (b) The candidates who have downloaded and got the same verified from District Court, Sangli, if the Admit Card is lost, misplaced or destroyed shall download fresh Admit Card from their respective login ID and produce the same before District Court, Sangli for verification and shall follow the instructions given in Hon'ble High Court of Bombay Notice dated 15.07.2024 at Point No. 2(a to c).


