With Reference to the subject noted above this is to inform you that, It has come in the notice of the Hon'ble Supreme Court that, the Disability Certificate issued by the various Doctors in the Motor Accident Claim Petition filed by the applicants have different formats of the certificate. So, Order of Hon'ble Supreme Court of India in W.P. (Civil) No. 534 of 2020 (Bajaj Allianz Gen.Insurance Co.ltd. v/s Union Bank of India and others.) gives the direction to the District Medical Officer to issue the Medical (Disability) Certificate in the prescribed format given under the guidelines issued by Ministry of Social Justice and Empowerment, Govt.Of India vide Gazette Notification S.No. 61, dated 05/01/2018 for issuance of Disability Certificate in order to bring uniformity. Kindly go through the notification for more details. The consequence is that the Tribunal would ascertain

that permanent Disability Certificate issued by the District Medical Board or the body authorised by it is in accordance with the Gazette Notification alone. Once the Certificate is issued in this manner, the same can be marked for purpose of being taken in to consideration as an evidence without necessity of summoning the concern doctor to give formal proof of the documents unless there is some reason for suspicion on the document.

So, It is to order you that kindly follow the guidelines issued in the above said notification for issuance of medical (Disability) Certificate in the Motor Accident Claim Cases.


