

A format of payment advised have already been implemented and office order of this tribunal vide letter dtd. 27-12-2021 has been passed and circulated to the Bar Association and to insurer companies as per the guidelines issued by The Hon'ble Supreme Court.

2	II, III	For Depositing the awarded amount in to a Tribunal Account.	<p>This Tribunal is to use the existing bank account for the purpose to receive the awarded amount. The insurer have been instructed to deposit the awarded amount through RTGS or NEFT in the said account. This Tribunal will also follow all the notification and circulars of the Hon'ble High Court of Gujarat for the payment in the claim cases.</p> <p>Separate Register (F.D) for the said purpose is maintained by the account Branch.</p> <p>All the stake holders, claimants and advocates have been instructed to follow the instruction of the Hon'ble Supreme Court guidelines as far as the payment of the claim is concern.</p>
3	IV	Medical Certificate as far as the aspect of issuing certificate on disability of victim is concerned,	<p>The District Medical Board, Morbi has already been instructed urgently vide letter no 2/2022, dtd. 03.01.2022 of this Tribunal to follow the guidelines issued by Ministry of Social Justice and Empowerment, Govt.Of India vide Gazette Notification S.No. 61, dated 05/01/2018, for issuance of Disability Certificate in order to bring Pan India Uniformity.</p>
4	V	Pan Card Details	<p>The Bar Association of Morbi, claimants have already been instructed urgently by this Tribunal to furnish the PAN Card details of the concern claimants in the Claim Petition. Moreover, The DLSA Morbi has been instructed to assist the claimant for obtaining the pan Card.</p>
5	VI	Submission of Compliance Report	<p>Crave leave to submit this compliance report</p>
6	VII to IX	Direction Contained under clauses VII to IX	<p>Not applicable to this Tribunal.</p>

7		Issuing of Summon along with report or the application for compensation as the case may be.	This Tribunal as per the guidelines issued by the Hon'ble Supreme Court is issuing the summon to the opponents along with the Claim petition, D.A.R., & A.I.R. and other relevant documents necessary.
8		Accident Information Report	This Tribunal has conveyed the Particular E-mail ID to the District Superintendent of Police, Morbi for sending of the Accident Information Report vide Notification No. MACP/387/2021, Dt. 27/12/2021.
9		Detailed Accident Report	The Concern Police Station will be instructed urgently by this Tribunal to collect the documents relevant to the accident and computation of compensation and to verify the information and documents and email the report to this Tribunal and insurer within Three Months as per the direction of Hon'ble Supreme Court. Similarly the clamaints may also be permitted to e-mail the application for compensation with supporting documents u/s 166 to the tribunal and the insurer within the same time.
