Sub:- Addition of certain fields in the Disposal/Unit Criteria Software for incorporation of data in compliance with the judgment dated 27.11.2020 in Karan v. State NCT of Delhi, CrI.A. No. 352/2020 and Sunny V. State NCT of Delhi, CrI.A.No. 353/2020.

The Hon'ble Full Bench of this Court vide judgment dated 27.11.2020 in Karan v. State NCT of Delhi, CrI.A. No.352/2020 and Sunny v. State NCT of Delhi, CrI.A.No.353/2020 has, inter alia, passed the following directions:-

"180. All the Courts below shall send a monthly statement to the Registrar General of this Court containing the list of cases decided each month. The list shall contain the name and particulars of the case; date of conviction; whether affidavit of assets and income has been filed by the accused; whether summary inquiry has been conducted to assess the compensation and determine the paying capacity of the accused; and compensation amount awarded. The monthly statement shall also contain one page summary format of the above information. The first monthly report for the period 01st January, 2021 to 31st January, 2021 be submitted by 15th February, 2021 and thereafter, by 15th of each English calendar month. The Registrar General of this Court shall place these reports before ACR Committee of the Judicial Officers."

In compliance with the aforesaid directions, the judicial officers of Delhi District Courts are required to send a monthly statement, which are to be placed before the Hon'ble Inspecting Judges' Committees of the said Judicial Officer/s.

In this context, the officers of Gaz.II-A Branch were called by Hon'ble Mr. Justice Sanjeev Sachdeva and his Lordship suggested that some additional fields may be got created in the Disposal/ Unit Criteria Software so that the concerned judicial officers can upload the data in compliance with aforesaid judgment pertaining to their respective Courts in the same for easy access by this Court.

It is, therefore, requested to please incorporate the following fields in the automated software (which has been already been created for updation of quarterly disposal statements by the judicial officers of District Courts) :
