**AMENDED PROTOCOL**

This is in reference to the directions issued by the Hon'ble High Court, conveyed through letter No. R-123/RG/DHC/2020 dated 30.04.2020 alongwith Minutes of Meeting of the Hon'ble Committee for Preparation of Graded Action Plan held on 28.04.2020 and in partial modification to Modified Protocol No.23/DJ/RADC/2020 dated 04.05.2020, **the cases in which arguments have already been heard and the order/judgment has been reserved, shall be given precedence.**

The Judicial Officers are also requested that since the reserved cases have already been **adjourned en-bloc** they must **fix fresh date(s)** of pronouncement.

It is advised that Ld. Officers **dictate the judgments/orders** from their **residence.**

While complying with the above directions, all the Ld. Officers of Rouse Avenue District Court shall ensure that the judgment is pronounced after **notifying the concerned counsel/parties**, the notices may be served **through electronic mode viz.** text messages, emails, telephone calls etc.

**Pronouncement of judgment be made through Video Conferencing.**

Further, Ld. Presiding Officers, Labour Courts and Industrial Tribunals, **may at their option**, start hearing the following category of matters, through **Video Conferencing:-**

- i) **Five years old cases at the final arguments stage.**
- ii) **Consent** of both the parties/counsels shall be taken for hearing of final arguments matters, through Video Conferencing.
- iii) **Video Conferencing facility** has already been installed at Work Station A, Room No. 011, Ground Floor, Near Main Entrance, Office 2, in Rouse Avenue District Court Complex, New Delhi **for those Advocates/Litigants** whose matters have been listed for hearing but who are not in a position to handle Video Conferencing from their respective homes/offices.
- iv) The **scanned copy** of the **judicial file** shall be made available.

**The Court hearings at the Court Complex are presently discouraged, till procurement/installation of necessary infrastructure at Rouse Avenue District Court Complex to meet the challenge of Covid-19 (Corona virus).**
