ORDER

Whereas a disciplinary proceeding against Mr. Ajay Goel, an officer of Delhi Higher Judicial Service is contemplated.

Now, therefore, this Court in exercise of the powers conferred by clause (a) of sub-rule (1) of Rule 3 of the All India Services (Discipline and Appeal) Rules, 1969 read with Rule 27 of Delhi Higher Judicial Service Rules, 1970, hereby places the said Mr. Ajay Goel under suspension with immediate effect.

It is also ordered that during the period of suspension, Mr. Ajay Goel will be paid subsistence and other allowances as admissible under the relevant rules.
