After getting the Registration Number the Court of learned Chief Judicial Magistrate, Vadodara is directed to enter the date of the particular case in the relevant Register maintained by the Court of the learned Chief Judicial Magistrate, Vadodara.

After registration and data entry, the learned Chief Judicial Magistrate, Vadodara is directed to allot the Criminal matters arising out of police stations mentioned hereunder in Column No. 3, in the Court mentioned hereunder in Column No.2, for hearing and disposal in accordance with law.
