
Note:-

- 3) Civil and Criminal Appeals/Applications under relevant Act/s be placed for institution, first order and final hearing before the Ld. Court, Which has been assigned the respective monthly business. In case any other court has decided any allied matters arising out of the same proceedings/subject matter, than, such subsequently instituted Civil and Criminal Appeals/Applications, be transferred to that particular court/s for first order and final hearing.
- 4) All Bail applications and other Criminal Misc. Applications shall be first placed before the Hon'ble Principal District Judge, Vadodara for admission and thereafter be allotted to other Courts.
