Pursuant to the Circular No. A(v) 438/2017, dtd.29/11/2017, issued by the Undersigned, the above named Metropolitan Magistrate, shall attend the Court, for Urgent work, for the Period between *After Office Hours, on working days, immediately falling before non-working Saturdays, Sundays and Holidays To Before Office Hours, on the next immediate working day after aforesaid non-working Saturdays, Sundays and Holidays*, as between 2 p.m. to 5 p.m. on non-working Saturdays, Sundays and Holidays, as shown against his/her name. However, in exceptional circumstances, the accused persons, may be produced at the residence of concerned Metropolitan Magistrate, beyond the aforesaid time. As per above the Circular dtd.29/11/2017 for the purpose of Urgent Charge, as above, the aforesaid Addl. Chief Metropolitan Magistrate, shall sit in the Court house of Court No.24, on the 2<sup>nd</sup> Floor of the Main Court Building.
