In exercise of the powers conferred upon me by Section 19[3] of the Code of Criminal Procedure 1974, read with Rule 10[i] of Chapter XXXII of Criminal Manual 1977, regarding the distribution of business amongst the Metropolitan Magistrate Courts, Ahmedabad, the following order of assignment of business, is further passed, so far as the Jurisdiction of Negotiable Instrument Act, 1881, Court No. 31 is concerned; so as to take **effect from 20/04/2024 [B.O.H.]**
