**OFFICE ORDER**  
**NO. A(VI) 42 OF 2024**

In view of Notification cited in the preamble at Sr. No.1, **Additional Chief Metropolitan Magistrate Court No. 16, Ahmedabad** is designated as "**Virtual Traffic Court**" for adjudicating RTO and Traffic Police eChallan Cases by "**Plead Guilty**" with jurisdiction for all Traffic eChallans under the Motor Vehicle Act, 1988.

Moreover, in supersession of the Office Order cited above at sr. No. (4) and in view of the administrative exigencies of this Court and the letters cited in the preamble Sr. No. 2 & 5, the undersigned is pleased to designate the Court of **Additional Chief Metropolitan Magistrate, Court No.06, Ahmedabad** of the Metropolitan Magistrates' Courts, Ahmedabad as "**Physical / Regular Traffic Court**" to try such cases i.e. *Traffic eChallan cases which are liable to be instituted from Virtual Traffic Court (Vcourt Module) to Physical Court (CIS Module)* opted to be contested and the such cases shall be transferred to "**Physical / Regular Traffic Court**" to try such cases, falling under the jurisdiction of these Courts, as per law.

This Office Order shall come into force with effect from **01/05/2024 (B.O.H)**.
