Eligibility Criteria:

1. Educational qualification: Minimum H.S passed with one year diploma in computer education from a reputed/recognized institute.
2. Age: Age limit not lower than 18 years and not exceeding 40 years as on 01.01.2023. The upper age limit will be relaxed as per Govt. rules.

How to Apply:

1. Applicants have to submit the filled up Standard Form (under Assam Gazette of Part - IX) along with all copies of self-attested documents like Age proof certificate, Educational qualification certificates, experience certificate, identity proof and address proof along with two recent passport size color photographs.
2. Candidate will submit the dully filled up application along with necessary documents and contact number/ email id written on the top of the application form at the Application Drop Box in the office of the District and Sessions Judge, Bajali during office hours.

Terms & Conditions:

1. The recruitment will be purely temporary and on contractual basis for a period of one year with no provision of regularization.
2. The last date of submission of application form is **26.07.2023.**

3. The candidates for the above mentioned post will be selected on the basis of a Computer skill test as well as viva-voce.
4. No TA/DA will be admissible to the candidates for appearing in the Computer Skill Test/ viva-voce.
5. Incomplete/ ineligible or late received applications will summarily be rejected.
6. If, information submitted by an applicant in his/her application found suppression of material facts including educational qualification, after selection, the same will be forfeited and criminal proceedings will be initiated for playing fraud and suppression of material facts and in such cases, candidate have no right to claim for selection and same will be filled up as per decision of the Selection Board and Board decision will be the final.
7. Candidate will be responsible for any mistake made by him/her in the application form.
8. No individual call letter will be sent to eligible candidates. However, Call letters for appearing in the Computer Skill Test/viva-voce for the said post will be uploaded in the official website of Bajali District Judiciary (<https://districts.ecourts.gov.in/bajali>) / Notice Board of this office.
