In view of the power conferred by sub-section (1) of Section (3) read with Section 3 (1-A) of the Commercial Courts Act, 2015 (4 of 2016), the Government of Gujarat has specified the Courts for the area of local limits of their jurisdiction as the Commercial Courts, for dealing with the Commercial disputes of the specified values and therefore, vide above referred notification cited at sr. no. (2), the undersigned has notified "commercial courts" for the area of local limits of jurisdiction as per the table appended therewith, for dealing with the Commercial disputes of the specified value in the Anand district.

Now, in view of preamble at sr. no.3, the undersigned is pleased to specify following courts shown in Column No. 2, for the area of local limits of their jurisdiction specified in Column No. 3 of the table appended hereunder, as the Commercial Courts, with effect from **29/08/2022 B.O.Hs.**, for dealing with the Commercial disputes of the specified value.
