ORDER

In partial modification of this office order bearing Endst.No.7822 dated 24.10.2024, Ms.Rajwant Kaur, Civil Judge (Sr. Divn)-cum-Addl. Chief Judicial Magistrate, Kapurthala is directed to visit Sub Division, Bholath on every **Wednesday and Friday instead of Monday and Tuesday** during the leave period of Ms.Shagun, Additional Civil Judge (Senior Division)-cum-Sub Divisional Judicial Magistrate, Bholath i.e. from 05.11.2024 to 04.05.2025 or from the date Ms.Shagun, Additional Civil Judge (Senior Division)-cum-Sub Divisional Judicial Magistrate, Bholath proceeds on leave till she resumes her duties, for disposal of Judicial Work of Sub Division Bholath. On rest of the working days, the Judicial Work of Sub Division, Bholath shall be dealt with by Ms.Rajwant Kaur, Civil Judge (Senior Division)-cum-Additional Chief Judicial Magistrate, Kapurthala at Headquarter, Kapurthala. All the fresh institution of the cases pertaining to Bholath Sub Division shall also be looked after/dealt with by Ms.Rajwant Kaur, Civil Judge (Senior Division)-cum-Additional Chief Judicial Magistrate, Kapurthala.

It is made clear that during the days of visit of Ms.Rajwant Kaur, Civil Judge (Senior Division)-cum-Additional Chief Judicial Magistrate, Kapurthala at Sub Division, Bholath, the Civil work including fresh institution as well as Administrative work of her Court shall be looked after by the Judicial Officer immediately junior to her in the hierarchy at the Headquarter, Kapurthala, whereas the Criminal work shall be looked after by the Duty Magistrate, Kapurthala, in addition to their own duties.

In case Ms.Rajwant Kaur, Civil Judge (Senior Division)-cum-Additional Chief Judicial Magistrate, Kapurthala happens to be on leave on account of any reason during the above said period, the urgent Civil Work shall be dealt with by the Subordinate Judicial Officer immediately junior to

her in the hierarchy at the Headquarter, Kapurthala and the Criminal cases shall be dealt with by the Duty Magistrate concerned during the leave period of Ms.Rajwant Kaur, Civil Judge (Senior Division)-cum-Additional Chief Judicial Magistrate, Kapurthala.

All concerned be informed accordingly.
