I. QUALIFICATIONS:

Any person

- a) Who has held any post in Andhra Pradesh Higher Judicial Service or State Judicial Services and retired or resigned or
- b) Who has held a post in the Andhra Pradesh Judicial Ministerial Service not below the rank of Superintendent of District Munsif's Court and has a Law Degree or
- c) Who has held a post of Section Officer and above in the Andhra Pradesh High Court Service and has a Law Degree or
- d) A non-practicing Advocate with a practice at the Bar of not less than five years and who is above 45 years of age, and obtained a <u>certificate of suspension of practice issued</u> by the Bar Association; or

- e) Any Gazetted Officer retired possessing Law Degree or who has passed the Criminal Judicial test (Full Test consisting of Indian Penal Code and the code of Criminal Procedure) conducted by the Andhra Pradesh Public Service Commission and who has exercised Magisterial powers during his tenure of service for not less than three years and
- f) who has at least one year to complete 65 years of age as on the date of the Notification.

Provided that a suitable retired Judicial Officer shall be preferred.

Note:-

- 1. The applicant who intends to submit his application under clause (d) shall enclose a certificate from competent authority to the effect that he had a practice at the Bar for not less than five years together with another Certificate of suspension of Practice issued by the State Bar Association.
- 2. In case the applicant is a Retired Officer of Revenue Department, a certificate from competent authority to the effect that he had exercised Magisterial powers for not less three years during his tenure of service in the Gazetted cadre shall be enclosed.
- 3. The posts noted at Sl. 5 to 8 are sanctioned under 13th Finance Commission the term of the Courts will be till 31-03-2022.

If any applicant intends to apply for more than one post, a separate application should be submitted for each post. Common Applications will be summarily rejected.

II.DIS-QUALIFICATIONS:-

A person

- 1. Who is a practicing advocate;
- 2. Who is member of any State or Legal Authority; and
- 3. Who is member of the State Legislature or of the Parliament; or
- 4. A person who having held an office under the State or the Union Government or any local authority has been dismissed or removed or compulsorily retired from service or subjected to any major penalty for mis-conduct.
- 5. A person who has been convicted and sentenced by a court for an offence involving moral delinquency or is charged of any offence constituting moral turpitude and proceedings are pending or
- 6. A person of unsound mind or who is deaf or mute or blind or suffering from leprosy or any other contagious disease; or
- 7. A person adjudicated as an insolvent or an un-discharged insolvent; or
- 8. A contractor or a business man or one interested in a subsisting contract or any work being done for central or State Government or a local Authority within whose limits the Special Judicial Magistrate has to discharge his duties; is not eligible.

III. REVOCATION OF POWERS OF SPECIAL MAGISTRATES:-

- a. On appointment and while in service a Special Judicial Magistrate of II Class may be removed without being called upon to show cause if he/she failed to attend three consecutive sittings of the court without the written permission of the Chief Judicial Magistrate.
- b. Powers conferred by the Court on Special Judicial Magistrate of Il Class shall automatically stands withdrawn on his/her attaining the age of 65 years.

The Last Date for receiving the applications is 22-03-2022. Applications received after 5-00 P.M., on 22-03-2022 and thereafter will summarily be rejected. Postal/Courier etc., delays Prl. District Judge, will not be considered.
