ORDER:-

The undersigned hereby issuing the following standing instructions with regard to conducting identification proceedings and recording statements U/Sec.164 Cr.P.C. The Officers mentioned in Col. No.2 have to conduct identification proceedings and to record Sec. 164 Cr.P.C. statements for the offences took place in the jurisdiction of the officers mentioned in Col. No.1. When ever any officer in Col. No.2 is on leave the officer who is incharge has to do the said work irrespective whether he is officer of the Court of I column. In any case where accused are on bail the officer whose jurisdiction the offence took place may direct the accused to appear before the officer conducting the identification parade at the place fixed by the officer conducting identification parade as provided U/Sec.54(A) Cr.P.C.
