Sub:- PUBLIC SERVICES – APJMSS – Recruitment to the posts under A.P. Judicial Ministerial and Subordinate Services in the Unit of District Judge, Prakasam at Ongole – Candidate selected for the post of Driver(LMV)(Category-14) by the Hon'ble High Court of Andhra Pradesh and allotted to the Unit of Prakasam District – Appointment Order to the newly selected candidate to the post of Driver – Orders – Issued.

ORDERS:-

The Hon'ble High Court vide reference 2nd cited issued Notification for filling-up of the post of Driver (LMV) (Category-14) in the District Judiciary in the State of Andhra Pradesh and conducted computer based online examination as per schedule noted in the reference 3rd cited. Further vide reference 4th cited published the list of eligible candidates for skill test to the post of Driver and vide reference 6th cited published list of candidates provisionally selected to the post of Driver(Light Vehicle) and directed to issue appointment orders after verification of the documents/certificates of the selected candidate subject to verification of antecedents by the concerned Police; In view of the same, the undersigned is pleased to issue the appointment order to the following selected candidate to the post of Driver :-

Sri Addala Satya Anil Kumar, S/o. Venkata Nagabhushanam, R/o.2-21, Thati-kayalavari Veedhi, Gudala Village, Allavaram Mandal, East Godavari District PIN- 533218; is temporarily appointed as Driver and posted as Driver in Chief Judicial Magistrate Court, Ongole; in the existing vacancy; On Joining duty, the individual is deputed to work in I-Addl. District & Sessions Court, Ongole, until further orders.

Note (N.B):-

1. The above candidate is informed that his appointment is purely on temporary basis and subject to verification of his character and antecedents by the concerned police and then subject to approval of the Hon'ble High Court.
2. The appointment of the above said candidate is purely on temporary basis and he is liable to be terminated at any time without assigning any reasons.
3. The selected candidate shall join in the post on or before 08-05-2023 but not later than 08-05-2023. If candidate does not join in the post within stipulated time, his appointment shall be treated as automatically cancelled. Any request from the individual for extension of time to join duty will not be considered.
4. At the time of joining duty; the above individual shall produce Physical Fitness Certificate issued by a Medical Officer not below the rank of Civil Surgeon.

5. The candidate is directed to produce (03) sets of attested copies of all certificates of his educational qualifications, proof of date of birth, caste certificate etc with duly filled attestation forms, Valid Driving License at the time of joining duty to send the same to the police for verification.
6. The individual appointed after 1-9-2004 are only covered by the "NPS" i.e., Contributory Pension Scheme and the pension scheme under A.P. Revised Pension Rules, 1980 will not be applicable to them as per G.O.Ms.No.653, 654 and 655 Finance (Pension-I) Department, Dated 22-9-2004.
7. The appointment of the candidates against "EWS"(Economically Weaker Sections) vacancies will, however be subject to the outcome of W.P. (Civil) No. 343/2019 and other cases, pending on the file of Hon'ble Supreme Court of India.
8. The individual shall submit a copy of proceedings of acceptance of Resignation, if he is employed in any other Department.
9. The above said newly appointed candidate is informed that, his appointment is subject to condition that, the employee shall execute a personal security bond of Rs.5,00,000/-(Rupees Five Lakhs), agreeing to serve the District Court, Prakasam for a period of 02(two) years from the date of joining the service and if the employee leaves the District Court Service for any reason whatsoever before completion of 02 years there from, he/she shall have to unconditionally make payment of Rs. 5,00,000/- to the Hon'ble High Court of Andhra Pradesh, the amount is an agreed compensation but not a penalty.
10. As per the Instructions of the Hon'ble High Court of A.P in ROC.No.19/2022-RC, dt:02-05-2023, the qualification for the post of Driver is (7th pass, 10th pass or fail or Intermediate or equivalent fail T.C.) as per notification. If the selected candidate for the post of Driver later found to have possessed more qualification than that what is asked for in the notification, during police verification or otherwise, such candidate will be summarily removed from the post besides launching Criminal Prosecution.
11. The individual is further informed that, in case of documents produced by him are found to have been created, manipulated or forged in the future date, they would be removed/dismissed beside launching criminal prosecution against him.
12. As per the Circular Instructions of the Hon'ble High Court in ROC.No.5417/88-C1 and in ROC. No.570/2023-C1, dt: 21-04-2023, the employees shall reside at the place of their respective working Station, they shall furnish residence address of the working station, they should not leave the station without prior sanction of leave or permission from their presiding officer concerned.
14. These orders are placed in the Official Website of Prakasam District and the downloaded copy is valid for relieving and reporting of the new incumbents.
