## ORDERS:-

The Hon'ble High Court vide reference 2nd cited issued Notification for filling-up of the posts of Junior Assistants(Category-8) in all the District Judiciaries in the State of Andhra Pradesh and conducted computer based online examination as per schedule noted in the reference 3rd cited. Further vide reference 4th cited, published the **Second** list of candidates provisionally selected to the post of Junior Assistant in District Judiciary (district wise) and the Hon'ble High Court vide its ref.5th cited directed to issue appointment orders after verification of the documents/certificates of the selected candidates, subject to verification of antecedents by the concerned Police; In view of the same, the undersigned is pleased to issue the appointment orders to the following newly selected candidates to the post of Junior Assistant:-

- 1. Kum. Kotikalapudi Jaya Lakshmi, D/o. Satyanarayana, Flat No. 102, Bhardwaja Residency, VIP Road, Lawyer Pet (Extension) Ongole -523002, Prakasam District; is temporarily appointed as Junior Assistant and posted as Junior Assistant in III-Addl. Junior Civil Judge's Court, Ongole, in the existing vacancy.

District & Sessions Court, Prakasam at Ongole, in the existing vacancy.

Senior Civil Judge's Court, Ongole, in the existing vacancy; on joining duty the individual deputed to work in Prl. Junior Civil Judge's Court, Ongole, until further orders.

Narasimha Rao, H.No.04-172, Ramnagar 2<sup>nd</sup> Line, Chimakurthy, Prakasam District -523226; is temporarily appointed as Junior Assistant and posted as Junior Assistant in Prl. Junior Civil Judge's Court, Kandukur, in the existing vacancy; On joining duty the individual is deputed to work in I-Addl. Junior Civil Judge's Court, Ongole, until further orders.
- 6. Sri Shaik Mohammed Vazeeruddin, Ahammed, S/o. Muzeebar Rahaman, H.No 20-293, Vijayabhaskar Nagar, Namburu, Peddakakani, Guntur District- 522508; is temporarily appointed as Junior Assistant and posted as Junior Assistant in Senior Civil Judge's Court, Kandukur, in the existing vacancy; On joining duty the individual is deputed to work in Prl. District & Sessions Court, Ongole, until further orders.
- 7. Sri Tanikonda Kotaiah, S/o. Koteswara Rao, H.No.13-104, Ambedkar Nagar, Inkollu Bapatla District-523167; is temporarily appointed as Junior Assistant and posted as Junior Assistant in Junior Civil Judge's Court, Darsi, in the existing vacancy; on joining duty the individual is deputed to work in Senior Civil Judge's Court, Markapur, until further orders.
- 8. Sri Maguluri Santosh Kumar, S/o. Maguluri Yacobu, H.No.2-106, Bethelpuram Donkakonda, Prakasam District- 523305; is temporarily appointed as Junior Assistant and posted as Junior Assistant in Junior Civil Judge's Court, Darsi, in the existing vacancy;
- 9. Kum Vadde Malakondamma, D/o. Vadde Venkata Kondaiah, Nagireddy Palli Village Veligandla Mandal, Prakasam District-523223; is temporarily appointed as Junior Assistant and posted as Junior Assistant in Junior Civil Judge's Court, Kanigiri, in the existing vacancy; On Joining duty, the individual is deputed to work in Addl. Junior Civil Judge's Court, Markapur, until further orders.

## Note(N.B):-

- 1. The selected candidates are informed that their appointments are purely on temporary basis and subject to verification of their character and antecedents by the concerned police and then subject to approval of the Hon'ble High Court.
- 2. The appointments of the above said candidates are purely on temporary basis and they are liable to be terminated at any time without assigning any reasons.
- 3. The selected candidates shall join in the post on or after 01-08-2023 but not later than 05-08-2023. If any candidate does not join in the post within the stipulated time, his/her appointment shall be treated as automatically cancelled. Any request from the candidates for extension of time to join duty will not be considered.
- 4 At the time of joining duty; the above individuals shall produce Physical Fitness Certificate issued by a Medical Officer not below the rank of Civil Surgeon.
- 5. The candidates are directed to produce (03) sets of attested copies of all certificates of their educational qualifications, proof of date of birth, caste certificate etc with duly filled revised attestation forms at the time of joining duty to send the same to the police for verification.
- 6. The individuals appointed after 1-9-2004 are only covered by the "NPS" i.e, Contributory Pension Scheme and the pension scheme under A.P. Revised Pension Rules, 1980 will not be applicable to them as per G.O.Ms.No.653, 654 and 655 Finance (Pension-I) Department, Dated 22-9-2004.

- 7. The Interse-seniority of the newly selected candidates will be fixed as per the directions of the Hon'ble High Court and neither the seriatum mentioned in these proceedings nor the dates of joining of the individuals is criterion to determine their seniority.
- 8 The appointment of the candidates against BC-E vacancies will, however be subject to the outcome of Civil Appeal Nos. 2628-2637/2010 pending for consideration before the Hon'ble Supreme Court of India.
- 9. The appointment of the candidates against Economically weaker sections 'EWS' vacancies will, however be subject to the outcome of W.P.(Civil) No.343/2019 and other cases, pending on the file of Hon'ble Supreme Court of India.
- 10. The individuals shall submit a copy of proceedings of acceptance of Resignation, if they are employed in any other Departments.
- 11. The individuals are further informed that, in case of documents produced by them are found to have been created, manipulated or forged in the future date, they would be removed/dismissed beside launching criminal prosecution against him/her.
- 12. The above said newly appointed candidates are informed that, their appointments are subject to condition that, the employee shall execute a personal security bond of Rs.5,00,000/-(Rupees Five Lakhs), agreeing to serve the District Court, Prakasam for a period of 02(two) years from the date of joining the service and if the employee leaves the District Court Service for any reason whatsoever before completion of 02 years therefrom, he/she shall have to unconditionally make payment of Rs.5,00,000/-to the Hon'ble High Court of Andhra Pradesh, the amount is an agreed compensation but not a penalty(it should be made on Rs.100/- Non Judicial Stamp paper duly notarazied)
- 13. The above said newly appointed candidates are informed that, within a month from the date of his/her appointment shall deposit an amount of Rs.10,000/- as security deposit for the due and faithfully performance of his /her duty, in compliance of Rule 22(b) of APJMSS Rules, 2019 otherwise they will be discharged from service.
- 14. As per the Circular Instructions of the Hon'ble High Court in ROC.No.5417/88-C1 and in ROC. No.570/2023-C1, dt: 21-04-2023, the employees shall reside at the place of their respective working Station, they shall furnish residence address of the working station, they should not leave the station without prior sanction of leave or permission.
- 15. The orders are placed in the Official Website of Prakasam District and the downloaded copy is valid for relieving and reporting of the new incumbents.
