ORDERS:-

The Hon'ble High Court vide reference 2<sup>nd</sup> cited issued Notification for filling-up of the posts of Office Subordinate(Category-17) in all the District Judiciaries in the State of Andhra Pradesh and conducted computer based online examination as per schedule noted in the reference 3<sup>rd</sup> cited. Further vide reference 4<sup>th</sup> cited, published the **Second** list of candidates provisionally selected to the post of Office Subordinate, in District Judiciary (district wise) and the Hon'ble High Court vide its ref.5<sup>th</sup> cited directed to issue appointment orders after verification of the documents/certificates of the selected candidates, subject to verification of antecedents by the concerned Police; In view of the same, the undersigned is pleased to issue the appointment orders to the following newly selected candidates to the post of Office Subordinate:-

1. Sri Ayila Koteswara Rao, S/o. Bala Kotaiah, H.No.10-153A, K. Pallepalem Village, Kothapatnam Mandal, Prakasam District-523286; is temporarily appointed as Office Subordinate/Attender and posted as Office subordinate/ Attender, Addl. Senior Civil Judge's Court, Ongole, in the existing vacancy.

Junior Civil Judge's Court, Kandukur in the existing vacancy.
8. Sri Shaik Sekshavali, S/o. Nazeer Ahammad, H.No.4-43A, Koneti Bazaar, Markapur, Prakasam District-523316; is temporarily appointed as Office Subordinate/Attender and posted as Office subordinate/Attender in Senior Civil Judge's Court, Markapur, in the existing vacancy.

Narasimha Rao, D.No.1-42, Chinthagumpalli Village, Podili Mandal, rakasam District-523253; is temporarily appointed as Office Subordinate/Attender and posted as Office subordinate/ Attender in, Special Court for speedy trial of offences under the Protection of Children from Sexual offences(POCSO)Act, 2012, Prakasam at Ongole, in the existing vacancy.



11. Sriram Purna Chandra Babu, S/o. Venkataiah, D.No.6-17, Kondareddy Palli Village, Vaggampalli Post, Pamuru Mandal, Prakasam District-523108 ; is temporarily appointed as Office Subordinate/ Attender and posted as Office subordinate/ Attender in III-Addl. Junior Civil Judge's Court, Ongole, in the existing vacancy, On joining duty the individual is deputed to work in Judge, Family Court-cum-VIII-Addl. District & Sessions Judge, Ongole, in the existing vacancy.

**Note(N.B):-**

1. The selected candidates are informed that their appointments are purely on temporary basis and subject to verification of their character and antecedents by the concerned Police and then subject to approval of the Hon'ble High Court.
2. The appointments of the above said candidates are purely on temporary basis and they are liable to be terminated at any time without assigning any reasons.
3. The selected candidates shall join in the post on or before 05-08-2023, but not later than 05-08-2023, If any candidate does not join in the post within the stipulated time, his/her appointment shall be treated as automatically cancelled. Any request from the candidates for extension of time to join duty will not be considered.
4. At the time of joining duty; the above individuals shall produce Physical Fitness Certificate issued by a Medical Officer not below the rank of Civil Surgeon.
5. The candidates are directed to produce (03) sets of attested copies of all certificates of their educational qualifications, proof of date of birth, caste certificate etc with duly filled attestation forms at the time of joining duty to send the same to the police for verification.
6. The individuals appointed after 1-9-2004 are only covered by the "NPS" i.e., Contributory Pension Scheme and the pension scheme under A.P. Revised Pension Rules, 1980 will not be applicable to them as per G.O.Ms.No.653, 654 and 655 Finance (Pension-I) Department, Dated 22-9-2004.
7. The interse-Seniority of the newly selected candidates will be fixed as per the directions of the Hon'ble High Court of A.P. and neither the seriatum mentioned in these proceedings nor the dates of joining of the individuals is a criterion to determine their seniority.
8. The appointment of the candidates against BC-E vacancies will, however be subject to the outcome of Civil Appeal Nos. 2628-2637/2010 pending for consideration before the Hon'ble Supreme Court of India.
9. The appointment of the candidates against "EWS"(Economically Weaker Sections) vacancies will, however be subject to the outcome of W.P.(Civil) No.343/2019 and other cases, pending on the file of Hon'ble Supreme Court of India.
10. The individuals shall submit a copy of proceedings of acceptance of Resignation, if they are employed in any other Departments.

11. The above said newly appointed candidates are informed that, their appointments are subject to condition that, the employee shall execute a personal security bond of Rs.5,00,000/- (Rupees Five Lakhs), agreeing to serve the District Court, Prakasam for a period of 02(two) years from the date of joining the service and if the employee leaves the District Court Service for any reason whatsoever before completion of 02 years there from, he/she shall have to unconditionally make payment of Rs.5,00,000/- to the Hon'ble High Court of Andhra Pradesh, the amount is an agreed compensation but not a penalty.
12. The individuals are further informed that, in case of documents produced by them are found to have been created, manipulated or forged in the future date, they would be removed/dismissed beside launching criminal prosecution against him/her.
13. As per the Instructions of the Hon'ble High Court of Andhra Pradesh in ROC.No.19/2022-RC, dt: 29-03-2023, If the selected candidates for the post of Office Subordinate/Attender are later found to have possessed more qualification than what is asked for in the Notification, during Police Verification or otherwise, such candidates will be summarily removed from the post besides launching Criminal Prosecution.
14. As per the Circular Instructions of the Hon'ble High Court in ROC.No.5417/88-C1 and in ROC. No.570/2023-C1, dt: 21-04-2023, the employees shall reside at the place of their respective working Station, they shall furnish residence address of the working station, they should not leave the station without prior sanction of leave or permission from their presiding officer concerned.
15. These orders are placed in the Official Website of Prakasam District and the downloaded copy is valid for relieving and reporting of the new incumbents.
