4. The relieving of the individuals at their deputation posts, is deemed to have been. relieved in their regular posts and they should proceed and to join in their new stations directly under intimation to his/her regular Court.
5. The transferred individuals shall hand over the detailed charge of their branches to his/ her successors as per the directions of their presiding officers.
6. The orders are placed in the official website of ecourts. Prakasam District, and downloaded copy of order is valid for relieving and reporting of employees.
