ORDERS:-

The Undersigned is pleased to pass the following order to come into force with immediate effect:-

I

1. Smt B. Umamaheswari, Senior Assistant (Category-7), Senior Civil Judge's Court, Addanki; is temporarily promoted as Superintendent (Category-3) of APJMSS Rules, 2019 and posted as Superintendent, Spl.
