ORDER

As per letter vide no. ASLSA /10/2014/Pt-1447 dated: 23.09.2024 received from Assam State Legal Services Authority, Guwahati, it was directed to reduce and resize the existing panels of Legal Aid Counsels/Lawyers under the DLSAs with immediate effect where LADCS has become functional. Accordingly, a new "Panel" of learned advocate/legal practitioners is prepared for providing legal aid and advice by prosecuting or defending the case as per National Legal Services Act, 1987 and NALSA (Free and Competent Legal Services) Regulations, 2010. For the purpose of providing effective and competent free legal aid to the entitled beneficiaries under Section 12 of the National Legal Services Authorities Act, 1987 and in view of introduction of the Legal Aid Defense Counsel System for defending all types of criminal cases, the panel of learned lawyers/legal practitioners notified vide Order dated 04/07/2024 of the Office of DLSA, Tinsukia for prosecuting or defending criminal cases before the learned courts situated within the jurisdiction of Tinsukia district is hereby reviewed. Accordingly, the aforesaid order is hereby modified and the following learned advocates/legal practitioners of Tinsukia /Margherita /Sadiya and JJB are selected for providing legal aid & advice w.e.f. 23/09/2024 for a period of 02 years or until further order, by prosecuting/defending/conducting the cases assigned to them as per the aforesaid Act and also in accordance with the NALSA (Free & competent Legal Services) Regulation 2010 other relevant Rules & Regulations. Also any case assigned to any learned Panel Advocate/Legal Aid Counsel in accordance with order no. 1 dated: 23/12/2023, order no.3 dated: 04/03/2024 and order dated: 04/07/2024 shall be continued to be prosecuted/defended/conducted by the learned Panel Lawyer already assigned.
