ORDER DT.05.05.2023.

In pursuance of the directions of the Hon'ble High Court of Andhra Pradesh, under 3rd and 7th read above, the Principal District Judge, Krishna, Machilipatnam, is pleased to pass the following continuation order:

Mutchu Nageswra Rao, S/o Pitchaiah, who is temporarily selected as Office Subordinate against Roaster Point No.16 of 8th Cycle (SC) (Local), is temporarily appointed as Office Subordinate and posted as Office Subordinate, Principal Junior Civil Judge's Court, Jaggaiahpeta, in the existing vacancy. H.T.No.22123010815.

N.B:

- 1. The above individual shall join in their posts on or before 08.05.2023 and the process of joining shall invariably complete by 08.05.2023 itself; failing which your name will be removed and no correspondence will be entertained in this regard.
- 2. The individual is further directed to produce a Physical Fitness Certificate issued by the Doctor not below the rank of Civil Asst. Surgeon at the time of joining duty.

- 3. The individual is hereby informed that his services are purely temporary and liable to be terminated at any time without notice or assigning any reasons.
- 4. The above appointment made shall be temporarily to start with; but however, the services of person will be regularized in the category of post to which he is appointed in due course, subject to verification of his antecedents.
- 5. The above individual is informed that if at all the documents produced by him are found to have been created, manipulated, interpolated or forged in future date, he will be removed/dismissed from the service besides launching Criminal prosecution against him.
- 6. The candidate in the proceedings if now working in other Department is directed to submit Relieving Certificate from the Employer and submit the same in Principal District Court, Krishna at Machilipatnam, before joining duty.
- 7. The individual is informed, his inter se seniority will be fixed as per your merit.
- 8. Selection against BC-E vacancy will, however, be subject to the outcome of Civil Appeal Nos.2628-2637/2010 pending consideration before the Hon'ble Supreme Court of India.
- 9. Selection against EWS vacancy will, however, be subject to the outcome of Writ Petition (Civil).No.343 of 2019 and other cases, pending on the file of the Hon'ble Supreme Court of India.
- 10. The Judicial Officer is requested to submit report to this Court by 11:00 A.M on 09.05.2023 stating that the newly recruited employee is joined or not in his respective court within the stipulated date as mentioned above, so as to submit the information to the Hon'ble High Court.
- 11. The Judicial Officer concerned is requested to obtain Personal Security Bond in favor of the "Principal District Court, Krishna, Machilipatnam" for a sum of Rs. 5,00,000/- from the individual if not submitted at the time verification of Original Certificates.
- 12. The respective Judicial Officer is requested to submit the Personal Security Bonds, Physical Fitness Certificate of the candidate to this Court, and intimate date of joining of the candidate.
