- 2. Since the transfers of the above individuals in Sl.No.2, 5, 7, 17, 24 to 26, 29, 43, 53, 55, 58, 61, 62, 64 to 68, 77, are considered at their requests. Hence, they are not entitled to claim any TTA and joining time.
- 3. Sl.No.1, 3, 4, 6, 8 to 1618, 19, 20, 21, 22, 23, 27, 28, 31 to 34, 36 to 42, 45, 46, 48, 52 and 54 are entitled to claim TTA and joining time.
- 4. The above individuals are directed to complete their pending work and shall hand over detailed charge list to the employees as directed by their respective Presiding Officers.
