I. QUALIFICATIONS:

A person

- i. Who has held any post in Andhra Pradesh Higher Judicial Services or State Judicial Service and retired or resigned; or
- ii. Who has held a post in the A.P. Judl. Ministerial Service not below the rank of Head Clerk of District Munsif's Court (Junior Civil Judge's Court) and has a Law Degree; or
- iii. Who has held a post of Section Officer and above in the A.P. High Court service and has a Law Degree; or
- iv. A non-practising Advocate with a practice at the Bar of not less than five years and who is above 45 years of age; or
- v. Any retired Gazetted Officer possessing Law Degree or who has passed the Criminal Judicial Test (full test consisting of the Indian Penal Code and the Code of Criminal Procedure) conducted by the A.P.Public Service Commission and who has exercised Magisterial powers during his tenure of service for not less than three years;

And who has at least one year to complete 65 years of age as on the date of Notification shall alone be eligible.

Preference will be given to a suitable retired Judicial Officer.

II. DISQUALIFICATIONS:

A person

- i. Who is practicing Advocate; or
- ii. Who is member of any State or Local Authority; or

- iii. Who is a member of the State Legislature or of the Parliament; or
- iv. A person who having held an office under the State or the Union Government or any local authority has been dismissed or removed or compulsorily retired from service or subjected to any other major penalty for misconduct; or

v. A person who has been convicted and sentenced by a Court for an offence involving moral delinquency or is charged of any offence constituting moral turpitude and proceedings are pending; or

vi. A person of unsound mind or who is deaf or mute; or blind or suffering from leprosy or any other contagious disease; or

- vii. A contractor or a business man or one interested in a subsisting contract or any work being done for Central or State Government or a local authority within whose limits the Spl. Magistrates have to discharge their duties;
- viii. A person adjudicated as an Insolvent or an undischarged insolvent shall not be eligible.
- III. The application for the above said posts should invariably contain the following particulars:
 - i. Name
 - ii. Father's Name
 - iii. Address for communication with cell phone No.
 - iv. Qualifications
 - v. Date of birth
 - vi. Date of retirement
 - vii. Name of the post to which applied
 - viii. Designation of the post at the time of retirement
 - ix. Period during which he/she exercised II Class Magistrate powers (proof of certificate to be Enclosed)
 - x. Other remarks, if any
- IV. Applications duly filled in should reach the undersigned on or before 10.7.23 d 5.00 pm, the later will not be considered.
- V. Documents to be submitted along with the application/bio-data:

Attested copies of:

- i. Date of birth certificate (first page of SSC or SSLC) and copy of proceedings issued at the time of retirement;
- ii. Certificates in proof of educational qualifications;
- iii. Proof of certificates regarding departmental tests passed (four papers test consisting of I.P.C. and Cr.P.C.);
- iv. Pension Payment Order;
- v. Service Certificate if available;
- vi. Proof exercising Magisterial powers together with period while in service in Gazetted post;
- vii. Non-practising certificate in case of Advocates and certificates showing practice at the Bar.

VI. Revocation of powers of Spl. Magistrates:

i. On appointment and while in service, a Spl. Magistrate of II Class or Spl. Magistrate of any other category may be removed without being called upon to show cause if he/she failed to attend three consecutive sittings of the Court without a written permission of the Chief Judicial Magistrate, as the case may be;

ii. Powers conferred by the Court on Spl. Judl. Magistrate of II Class or Spl. Magistrate of any other category shall automatically stand

withdrawn on his/her attaining the age of 65years.

VII. Other conditions:

i. Applications with insufficient information and without proof of certificates will be rejected and no further correspondence will be entertained.

ii. The undersigned reserves right to cancel this Notification at any time without assigning any reasons.
