**ORDER DT.23.06.2023.**

In pursuance of the directions of the Hon'ble High Court of Andhra Pradesh, under 6<sup>th</sup> read above, the Principal District Judge, Krishna, Machilipatnam, is pleased to pass the following order:

Sri Kota Chandu, S/o.Chinna Subba Rao, who is working as Office Subordinate, III Addl. District Court, Vijayawada and who is temporarily selected as Driver (Light Vehicle) against Roster Point No.07 of 1<sup>st</sup> Cycle (SC) (Local), is temporarily appointed as Driver (Light Vehicle) and posted as Driver (Light Vehicle), Prl. Senior Civil Judge's Court, Vijayawada, in the existing vacancy. H.T.No.22123040047, by shifting from the post of Office Subordinate as a onetime measure.

Further, the individual is deputed to work in the III Addl. District Court, Vijayawada, until further orders.

1. The above individual shall join in his new post forthwith.
2. The individual is hereby directed to furnish security of a sum of Rs.10,000/- (Rupees ten thousand only) for the post of Driver (Light Vehicle), within one month from the date of his joining as prescribed under Rule 22 of A.P.J.M.S.S.Rules, 2019 for the due and faithful performance of duties entrusted to him.
3. The individual is hereby informed that his services are purely temporary and liable to be terminated at any time without notice or assigning any reasons.
4. The above appointment made shall be temporarily to start with; but however, the services of person will be regularized in the category of post to

which he/she is appointed in due course, subject to verification of his antecedents.

5. The above individual is informed that if at all the documents produced by him are found to have been created, manipulated, interpolated or forged in future date, he will be removed/dismissed from the service besides launching Criminal prosecution against him.
6. The individual is informed, his inter se seniority will be fixed as per his merit.
