#### N.B:

1. All the above individuals shall join in their posts on or after 01.08.2023 to on or before 05.08.2023 and the process of joining shall invariably complete by 05.08.2023 itself; failing which their names will be removed and no correspondence will be entertained in this regard.

- 2. The individuals are further directed to produce a Physical Fitness Certificate issued by the Doctor not below the rank of Civil Asst. Surgeon at the time of their joining duty.
- 3. The individuals are hereby directed to furnish security of a sum of Rs.10,000/- (Rupees ten thousand only) for the post of Junior Assistant, within one month from the date of their joining as prescribed under Rule 22 of A.P.J.M.S.S.Rules, 2019 for the due and faithful performance of duties entrusted to them.
- 4. The individuals are hereby informed that their services are purely temporary and liable to be terminated at any time without notice or assigning any reasons.
- 5. The above appointments made shall be temporarily to start with; but however, the services of persons will be regularized in the category of post to which he/she is appointed in due course, subject to verification of their antecedents.
- 6. The above individuals are informed that if at all the documents produced by them are found to have been created, manipulated, interpolated or forged in future date, they will be removed/dismissed from the service besides launching Criminal prosecution against them.
- 7. The candidates in the proceedings who are now working in other Departments are directed to submit Relieving Certificate from their Employer and submit the same in Principal District Court, Krishna at Machilipatnam, before joining duty.
- 8. The individuals are informed that their inter se seniority will be fixed as per their merit.
- 9. Selection against BC-E vacancy will, however, be subject to the outcome of Civil Appeal Nos.2628-2637/2010 pending consideration before the Hon'ble Supreme Court of India.
- 10. Selection against EWS vacancy will, however, be subject to the outcome of Writ Petition (Civil).No.343 of 2019 and other cases, pending on the file of the Hon'ble Supreme Court of India.
- 11. The Judicial Officers are requested to submit report to this Court by 11:00 A.M on 07.08.2023 stating that the newly recruited employees are joined or not in their respective courts within the stipulated date as mentioned above, so as to submit the information to the Hon'ble High Court.
- 12. The Judicial Officers concerned are requested to obtain Personal Security Bond in favor of the "Principal District Court, Krishna, Machilipatnam" for a sum of Rs.5,00,000/- from the individuals those who have not submitted at the time verification of Original Certificates.
- 13. The respective Judicial Officers are requested to submit the Personal Security Bonds, Physical Fitness Certificate of the candidates to this Court, and intimate date of joining of the candidates.
