## ORDER DT.11.08.2023.

In pursuance of the directions of the Hon'ble High Court of Andhra Pradesh, under 2<sup>nd</sup> read above, the Principal District Judge, Krishna, Machilipatnam, is pleased to pass the following order:

- Devi Sampurna Kummari, D/o K V Satya Arjuna Rao, who is temporarily selected as Copyist, is temporarily appointed as Copyist and posted as Copyist, II Additional District Court, Vijayawada, in the existing vacancy. H.T.No.22122026890.
- Gandikota Venkata Ratnam, D/o Gandikota Narasimha Rao, who is temporarily selected as Copyist, is temporarily appointed as Copyist and posted as Copyist, II Additional District Court, Vijayawada, in the existing vacancy. H.T.No.22122011562.

## N.B:

- 1. The above individuals shall join in their post on or before 18.08.2023 and the process of joining shall invariably complete by 18.08.2023 itself; failing which their names will be removed and no correspondence will be entertained in this regard.
- The individuals are further directed to produce a Physical Fitness Certificate issued by the Doctor not below the rank of Civil Asst. Surgeon at the time of joining duty.
- 3. The individuals are hereby directed to furnish security of a sum of Rs.10,000/- (Rupees ten thousand only) for the post of Copyist, within one month from the date of their joining as prescribed under Rule 22 of A.P.J.M.S.S.Rules, 2019 for the due and faithful performance of duties entrusted to them.
- 4. The individuals are hereby informed that their services are purely temporary and liable to be terminated at any time without notice or assigning any reasons.
- 5. The above appointments made shall be temporarily to start with; but however, the services of persons will be regularized in the category of post to which he/she is appointed in due course, subject to verification of their antecedents.

- 6. The above individuals are informed that if at all the documents produced by them are found to have been created, manipulated, interpolated or forged in future date, they will be removed/dismissed from the service besides launching Criminal prosecution against them.
- 7. The candidates in the proceedings if now working in other Department is directed to submit Relieving Certificate from the Employer and submit the same in Principal District Court, Krishna at Machilipatnam, before joining duty.
- 8. The individuals are informed that their inter se seniority will be fixed as per their merit.
- 8.The Judicial Officers are requested to submit report to this Court by 11:00 A.M on 19.08.2023 stating that the newly recruited employees are joined or not in the respective courts within the stipulated date as mentioned above, so as to submit the information to the Hon'ble High Court.
- The respective Judicial Officers are requested to submit the Physical Fitness Certificates of the candidates to this Court, and intimate date of joining of the candidate.
