ORDER DT.11.08.2023.

In pursuance of the directions of the Hon'ble High Court of Andhra Pradesh, under 2nd read above, the Principal District Judge, Krishna, Machilipatnam, is pleased to pass the following order:

D Solomonraju Pallikonda, S/o P. Solomon Raju, who is temporarily selected as Typist, is temporarily appointed as Typist and posted as Typist, Senior Civil Judge's Court, Nuzvid, in the existing vacancy. H.T.No.22121022595.

Further, the individual is deputed to work in the V Additional Junior Civil Judge's Court, Vijayawada, until further orders.

N.B:

1. The above individual shall join in his post on or before 18.08.2023 and the process of joining shall invariably complete by 18.08.2023 itself; failing which his name will be removed and no correspondence will be entertained in this regard.
2. The individual is further directed to produce a Physical Fitness Certificate issued by the Doctor not below the rank of Civil Asst. Surgeon at the time of joining duty.
3. The individual is hereby directed to furnish security of a sum of Rs.10,000/- (Rupees ten thousand only) for the post of Typist, within one month from the date of his joining as prescribed under Rule 22 of A.P.J.M.S.S.Rules, 2019 for the due and faithful performance of duties entrusted to him.
4. The individual is hereby informed that his services are purely temporary and liable to be terminated at any time without notice or assigning any reasons.
5. The above appointment made shall be temporarily to start with; but however, the services of persons will be regularized in the category of post to which he/she is appointed in due course, subject to verification of his antecedents.
6. The above individual is informed that if at all the documents produced by him are found to have been created, manipulated, interpolated or forged in future date, he will be removed/dismissed from the service besides launching Criminal prosecution against him.

7. The candidate in the proceedings if now working in other Department is directed to submit Relieving Certificate from the Employer and submit the same in Principal District Court, Krishna at Machilipatnam, before joining duty.
8. The Judicial Officers are requested to submit report to this Court by 11:00 A.M on 19.08.2023 stating that the newly recruited employee is joined or not in the respective court within the stipulated date as mentioned above, so as to submit the information to the Hon'ble High Court.
9. The respective Judicial Officers are requested to submit the Physical Fitness Certificate of the candidate to this Court, and intimate date of joining of the candidate.
