The Principal District Judge, Krishna, Machilipatnam, is pleased to pass the following order:

The under-mentioned Process Servers were directed to discharge the duties of feeder categories as per the proceedings 1st read above, due to dearth of Class-IV employees in the District.

Now, in view of the recent recruitment conducted by the Hon'ble High Court under 2nd read above, the following Process Servers are relieved from discharging the duties of their feeder category and now onwards they shall have to discharge the duties of their promotion post of Process Server.
