- 5) The presiding Officer is requested to obtain Physical Fitness Certificate issued by the Government Doctor not below the rank of Civil Assistant Surgeon at the time of her joining and submit the same to the District Court, Krishna, Machilipatnam.
- 6) The above individual is directed to join duty immediately.
