- 2) The appointment of the above individuals are liable to be terminated at any time without assigning any reasons and without issuing any notice.
- 3) The above individuals are entitled for remuneration as per Rules in vogue.
- 4) The Presiding Officers are requested to obtain the Deed of Agreement from the individual on Non-Judicial Stamp of worth Rs.100/- duly filled in initially up to 30.04.2024 during the current Financial year and submit the same to the District Court, Krishna, Machilipatnam.
- 5) The Presiding Officers are requested to obtain Physical Fitness Certificate issued by the Government Doctor not below the rank of Civil Assistant Surgeon at the time of their joining and submit the same to the District Court, Krishna, Machilipatnam.
- 6) The above individuals are directed to join duty immediately.
