- b. Must have passed A.P.Govt. technical examination in English Typewriting by Higher Grade and must have passed A.P. Govt. Technical examination in English Shorthand by Higher Grade or equivalent examination.
- c. Provided that if candidates who have passed the examination by Higher Grade in English Shorthand are not available, those who have passed the examination by Lower Grade will be considered; and
- d. Must have knowledge or qualification in computer operation.

II. AGE:

Must have completed the age of 18 years and must not have completed the age of 42 years as on 01.07.2024. Age relaxation of 05 (five) years shall be given in respect of the candidates belonging S.Cs., S.Ts., and B.Cs.
