In view of Notification No-HC.VIII-76/2019/2939/AC dated 07.05.2021 of the Hon'ble Gauhati High Court authorizing the Establishments of District Judiciary of Assam to 'outsource the vehicles with chauffer (if required), *inter alia*, for the officers whose vehicles are declared 'condemned' and have not been provided with new vehicles, and subsequent notice inviting tender/quotation dated 07.07.2022 by this office and extension of the said tender dated 25.07.2022 and in terms of Resolution of the Board dated 04.08.2022, in respect of outsourcing of 1 (one) vehicle for the undersigned, the quotation/tender of one Mr. Zakir Hussain Barbhuiya, for supplying **MAHINDRA SCORPIO S11 M** vehicle bearing **Reg.
