Terms and Conditions:-

1. Duly filled-up application form must be accompanied by self-attested copies of all testimonials including educational qualification certificate, age proof certificate etc and at least 2(two) copies of recent passport size photograph.
2. Candidates with Computer proficiency will be given preference.
3. Duly filled up application form must be addressed to the District & Sessions Judge, Karimganj and the envelope containing the application must be dropped in the Drop Box kept in front of the Court of the undersigned.

4. The last date for submission of application is **16.05.2024**, and no application will be entertained after the closing date.
5. Eligible candidates will have to appear in a written test for 20 marks to be followed by viva-voce of 40 marks. Thus, in total, the entire test will be of 60 marks, out of which 36 (60%) would be the cut off marks for qualifying for promotion and any candidate not securing the said cut-off marks (i.e. 36 marks) will not be considered for promotion. Probable date of written test and viva-voce is 17.05.2024.
