Applications are invited from the eligible candidates, who are citizens of India as defined in Article 5 to 8 of the Constitution of India, in Standard Form as published in **Part-IX** of the Assam Gazette, for engagement of **01 (one)** number of **Driver on contingency basis** for the official vehicle of the Civil Judge (Sr. Div), Karimganj, **at a fixed pay of Rs. 15,000/- per month**, under the establishment of the District & Sessions Judge, Karimganj.

TERMS AND CONDITIONS

1. Candidates must be an Indian citizen as per the Constitution of India.
2. Candidates must not be less than 18 years of age and must not be more than 40 years of age as on 01.01.2024. The upper

age limit relaxation shall be applicable as per the existing rules of the Govt. of Assam.

3. Candidates must have registered their names in the Employment Exchange and the Registration Numbers along with date must be mentioned in the applications.
4. Candidates must have passed Class-VIII and must not have passed HSSLC.
5. If any candidate is found to have suppressed his educational qualifications or given wrong information, at the time of applying for the said post, his candidature shall stand rejected without any information to him with immediate effect and shall also be liable to criminal prosecution as per law.
6. Candidates who are already in Government Service (Central/State or PSU) shall have to apply through proper channel along with "No Objection Certificate".
7. The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card, Professional Driving License and Experience Certificate along with 03 (three) copies of recent passport size photographs, duly signed by the candidate on the reverse side, should reach the office of the District & Sessions Judge, Karimganj on or before last date of receipt of application(s).
8. Candidates must provide their email address and mobile phone number in the application form, without fail.
9. The candidates must indicate prominently the name of the post applied for on the top of the envelope containing the application.

10. The last date of receipt of applications is **24.07.2024**. Applications will be received through **offline mode only**. No application will be entertained after the last date. The Appointing Authority shall not be responsible under any circumstances for any postal delay.
11. Eligible candidates for the post of Driver will have to appear for Skill/Driving Test and Viva-Voce/Interview.
12. The accepted/rejected list of candidates for the post of Driver will be uploaded in the official website of Karimganj District Judiciary (**<https://karimganj.dcourts.gov.in>**) in due course of time.
13. No individual Call Letter/Admit Card will be sent to the eligible candidates. They will have to download the same from the official website of Karimganj District Judiciary (**<https://karimganj.dcourts.gov.in>**).
14. Complete applications along with all testimonials as mentioned above are to be addressed to the "The District & Sessions Judge, Karimganj, Assam-788710" through post or may be dropped in the Drop Box which will be placed in front of the office.
15. The applications will be subject to scrutiny at every stage and shall be rejected if any anomalies are found or detected. Incomplete applications will be rejected summarily.
16. The date, time and venue of the Skill/Driving Test and Viva-Voce/Interview will be notified in due course of time through official website of Karimganj District Judiciary (**<https://karimganj.dcourts.gov.in>**).
17. No TA/DA shall be paid to the candidates for appearing in the

Skill/Driving Test and Viva-Voce/Interview.

18. No person who has entered into or contracted a marriage with a person having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the aforesaid post of Driver.
19. Candidates at the time of applying for the aforesaid post of Driver shall have to submit a Declaration in Form-"A" under Rule 5(1) of the Assam Public Services (Application of Small Family Norms in Direct Recruitment) Rules, 2019 and application without "Form-A" shall be liable to rejection.
