TERMS AND CONDITIONS FOR APPLICATION:


1. Candidate must be an Indian Citizen as per the Constitution of India.
2. Candidate should not be less than 18 years and not more than 40 years as on 01-01-2026. Upper Age Limit relaxation shall be as per existing government guidelines.
3. Candidates must have registered their names in the Employment Exchange and the Registration numbers along with date must be mentioned in their applications.
4. Candidates who are already in Govt. Service will have to apply through proper channel along with NOC from his/her employer.
5. The applications with self-attested photocopies of all relevant testimonials relating to Educational Qualification, Experience (wherever applicable), Caste, Age proof, Employment Exchange

Registration Card, along with 03 (three) copies of recent passport size photographs duly signed by the candidate on the reverse side, should reach the office of the District & Sessions Judge, Sribhumi on or before the closing date.

6. Candidates must provide their email address and mobile phone number in the application, without fail.
7. Candidates must indicate prominently the name of the post applied for on the top of the envelope containing the application.
8. The last date of receipt of application is **25.05.2026 (upto 05:00 P.M.)**. The applications will be received through **offline mode only**. No application will be entertained after the last date. The appointing authority shall not be responsible for any postal delay.
9. Eligible candidates for the post of Driver will have to appear for skill test and viva-voce.
10. The accepted list/rejected list of candidates for the post of Driver will be uploaded in the official website of Sribhumi District Judiciary (**<https://karimganj.dcourts.gov.in>**) in due course of time.
11. No individual Call Letter/Admit Card will be sent to the eligible candidates. List of eligible candidates to be called for appearing in skill test/ viva-voce will be uploaded in the official website of Sribhumi District Judiciary (**<https://karimganj.dcourts.gov.in>**) and candidates will have to download the same from the official website. The reject list of candidates will also be uploaded in the official website.
12. No person, who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the aforesaid post of Driver.
13. Candidates at the time of applying shall have to submit a Declaration in Form-"A" under Rule 5(1) of the Assam Public
