(Revised Notice Inviting Quotation for Purchase of Condemned Vehicles for Scrapping)

Office of the District & Sessions Judge, Nagaon proposes to dispose off following Govt. Vehicle lying idle at one of the Assam Type Residential Quarter of the District Judiciary, Hojai (Erstwhile Judicial Sub Division, Hojai under District Judiciary, Nagaon) on "as is where basis" for scrap purposes.

Accordingly, sealed quotations affixing non refundable court fee stamp of Rs.8.25 (Rupees Eight and paisa twenty five) only are invited for the disposal of the above mentioned vehicle on the terms and conditions mentioned below. The quotations addressed to the undersigned in a sealed cover should reach the office of the undersigned latest by 12.00 noon on 20th December, 2024. The quotations received within stipulated time will be opened at 12.30 PM on the same day i.e. 20.12.2024. The quotations should be dropped in the Quotation Box at the office of the undersigned. The cover should be prominently super scribed with the words "Quotation for Purchase of Condemned Vehicles for Scrapping". The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotation.

Terms and condition of the auction:

- (i) The bidder must be a Registered Vehicle Scrapping Facility (RVSF) of Assam. The bidder must submit the RVSF registration. The bidder should mention his full name, address, whatsapp number in the quotation
- (ii) The bidder should submit copy of PAN and GST registration in the name of the RVSF firm.
- (iii) The vehicle is available for inspection at the site as stated in the para 1 of this document. The undersigned shall not be responsible and shall not entertain any complaint in respect of any defect in the vehicles.

- (iv) The bidder has to quote price for entire lot of vehicles which shall be higher than or equal to the Reserved Price.
- (v) The successful bidder has to deposit the bid amount in the District Treasury in appropriate head of account and furnish the deposit receipt to the office of the undersigned. The bid amount is excluding GST, hence the GST as applicable is to be paid by the bidder separately for the said vehicles after which the formal order to lift the said vehicles will be issued by the undersigned.
- (vi) The successful bidder will have to take delivery of the vehicles within seven days of issuance of formal order to lift the said vehicles, failing which the undersigned shall forfeit the bidder's right over the vehicles and process will be initiated for handing over the vehicles to the second highest bidder at H-1 rate or cancellation of the bid process.
- (vii) The successful bidder will remove the sold vehicles within seven days of depositing the value at his or her own expenses. The undersigned will not be responsible for the safety of the vehicles.
- (viii) The vehicles will be disposed off on "as is where basis is".
- (ix) The purchaser will be responsible for future legal matters whatsoever, pertaining to the vehicle after taking delivery.
- (x) The undersigned reserves the right to accept or reject any/all of the quotations partly or completely, at any time without assigning any reason thereof. The decision of the undersigned conducting the auction shall be final.
- (xi) The quotations below the reserved price will not be entertained and to be rejected.
- (xii) The undersigned will deal with the bidder directly and no middlemen/ agents/ commission agents etc. should be asked by the bidders to represent their cause and they will not be entertained by the undersigned. At the bidding, any bidder trying to form cartel with other bidders to otherwise influence the bidding process may be evicted.
