## **CIRCULAR**

Sub: Small quantity offences under the Narcotic Drugs and Psychotropic Substances Act, 1985 certain instructions issued to the Judicial Magistrates of First Class in Nagaon-Regarding.

It has been brought to the notice of the undersigned that the Judicial Magistrates of First Class in the Nagaon District are forwarding all the accused to the Special Courts constituted under the Narcotic Drugs and Psychotropic Substances Act, 1985 in Nagaon particularly those cases which are not triable by the Special Courts.

Section 36A (I)(a) of the NDPS Act, 1985, provides that all the offences under the said Act which are punishable with imprisonment for a term of more than 3 years shall be triable only by the Special Court.

The said provision read with Section 4(2) and Section 5 of the Bharatiya Nagarik Suraksha Sanhita, 2023, clearly suggests that those offences under the NDPS Act which are not punishable with imprisonment of more than 3 years are to be tried by any Magistrates including Judicial Magistrate of the 1<sup>st</sup> Class and for such purposes the provision of Bharatiya Nagarik Suraksha Sanhita, 2023 are to be generally followed, except where expressly excluded or applied with further modifications under the NDPS Act, 1985.

From the above, it appears that the Magistrate of First Class may try the following offences under the NDPS Act:

Therefore, all the Judicial Magistrates of First Class in Nagaon District are directed not to Forward accused involved in the aforesaid offences, to the Special Courts constituted under the NDPS Act in Nagaon and to try such offences in their

respective jurisdiction/Courts only in terms of provisions laid down in the NDPS Act read with the provisions of the BNSS, 2023.

This is for implementation with immediate effect.
