**ADVERTISEMENT**

Applications are invited from local residents in standard form along with two number of passport size photographs, for selection of PLVs' who are willing to serve as Para Legal Volunteer at Nagaon District under **District Legal Services Authority, Nagaon**. The applicants should have the following qualifications to apply for the selection of Para Legal Volunteers.

1. He/she must be a citizen of India and should be from any one of the following groups:-

- Teachers (including retired teachers).
- Retired Govt. Servants and Senior Citizens.
- Students and Teachers of Master of Social Work.
- Anganwadi Workers.
- Doctors/Physicians.
- Students & Law Students (till they enroll as lawyers)
- Members of Non-political, service oriented NGOs and Clubs.
- Members of Women Neighbourhood Groups, Maithri Sangrams, and other Self Help Groups including Marginalised/Vulnerable Groups.
- Any Social Worker.
- Persons from defence background or their family members
- Any other person whom the District Legal Services Authority deems fit to be identified as PLVs.

2. The applications should pass minimum matriculation with a capacity for overall comprehension and should have mindset to assist the needy in society coupled with compassion, empathy and concern for upliftment of marginalised and weaker sections of society.

3. Preferably the PLVs shall be selected from those who do not look up to the income they derive from their services as PLVs, but should have a mindset to assist the needy in society. Preference shall also be given to candidates who have proficiency in driving (four wheelers), and proficiency in computers (MS Office).

4. The minimum age for selection of PLVs should not be less than 21 years as on date of notice.

5. The work of PLVs does not carry any salary, remuneration or wage except honorarium fixed from time to time, as per rules.

6. The envelope containing the application form should be addressed to **"THE DISTRICT & SESSIONS JUDGE-CUM-CHAIRMAN, DISTRICT LEGAL SERVICES AUTHORITY, NAGAON, ASSAM, PIN-782001"**. The filled up applications should reach the office of the District Legal Services Authority, Nagaon, on or before **05:00 P.M** of **25.08.2026**. The applicants should submit their **mobile numbers** in their application forms for further communication, if any. The applicants must submit their application along with self-attested documents in a sealed envelope and deposit the same in the **"DROP BOX"** provided for the purpose in the premises of the **District & Sessions Judges' Court, 4<sup>th</sup> Floor, Judicial Court Building at Nagaon**.

7. Incomplete applications will be rejected. No applications will be entertained after the last date fixed.

8. The decision of Selection Committee in short listing the number of candidates for viva-voce/interview and selection of PLV shall be final. They will be selected as per relevant scheme, in this regard.
9. The PLVs who are at present a part of District Legal Services Authority, Nagaon will need to apply afresh, failing which they will be considered to have failed to evince interest in the scheme. Applying afresh also does not guarantee Selection, the decision of Selection Committee in short listing the number of candidates for viva-voce/interview and selection of PLV shall be final.
10. In case of any objection regarding selection of PLVs the decision of Chairman, District Legal Services Authority, Nagaon, shall be final and binding to all concerned.
11. List of short listed, eligible candidates, if any, will be notified in the official notice board as well as uploaded in the official website of Nagaon Judiciary for interview. No separate call letter will be issued from this office.
12. Canvassing directly or indirectly will disqualify the candidate.
13. No TA/DA will be provided for appearing in the interview.
