**MISC. ORDER NO. 358 /2023**

In Continuation of Misc. Order No. 327/2023 dated 30.08.2023, for the smooth functioning in view of preventive measures against spreading of Coronavirus (COVID-19) and for reducing the risk of infection in the premises and around of Civil Court, Purnea. It has been ordered to the Jail Superintendent, Central Jail, Purnea not to produce prisoners from Jail to the Court as a preventive measures to avoid the crowding. Accordingly, all U.T.P. of Sessions Cases and Trial Cases will be produced from Jail to Court through Video Conferencing w.e.f. 18.03.2020, is hereby **further extended till 31.10.2023** and in view of the directions contained all the Trial Courts (Sessions & Magisterial Trial Cases) are directed to send the list of cases along with name of U.T.P. to the Central Jail, Purnea and copy to Video Conferencing Room at Civil Court, Purnea at once for today only and preferably one day before. So that the Jail Superintendent, Central Jail, Purnea may produce the U.T.P. through Video Conferencing. No U.T.P. will produce physically before the Court except some special circumstances. The Court concern may order for the same.
