PREAMBLE:

With reference to the subject cited above, on going through the statistical information of the Courts of III Addl.Senior Civil Judge, Davanagere, Principal Civil Judge & JMFC, Honnali, II Addl.Civil Judge & JMFC, Davanagere and III Addl.Civil Judge & JMFC, Davanagere, we committee members noticed that there are huge pendency of criminal cases in the said Courts, whereas the Criminal Cases pertaining to I Addl.Senior Civil Judge & JMFC, Davanagere, I Addl.Civil Judge & JMFC, Davanagere, IV Addl.Civil Judge & JMFC, Davanagere and Addl.Civil Judge & JMFC, Honnali are less.

As per the letter under reference No.1 and as per the decision of the District Case Management Committee, with an intention to reduce the arrears of criminal cases and to timely dispose off the cases and as per the guidelines

referred in the reference letter, DCMC has decided to redistribute the criminal cases from the aforesaid four courts to other four courts for the disposal in accordance with law.

I being the Principal District & Sessions Judge, Davanagere and Chairman of DCMC committee and in exercise of the powers conferred upon me, as contemplated U/S.448 of BNSS-2023, for quick disposal of criminal cases and to reduce the pendency/arrears reduction, proceeded to pass the following:




