Hon'ble The Principal District and Sessions Court, Aurangabad is to  
sell scrap documents of the records in District Central Record Section.

Accordingly, tenders are being invited from Government approved  
scrap buyers. However, interested Government approved scrap buyers  
should submit their tenders in the sealed envelope in the office of District  
Central Record Section, District and Sessions Court, Aurangabad on or  
before 06.08.2024 by 05.00 PM. Any subsequent tender will not be  
accepted.

**Following are the Terms and Conditions for buying scrap.**

- 01) The scrap rate indicated in the tender shall not be less than ruppees  
18.00 per kilogram ( Literal Rupees Eighteen ).
- 02) Cheque of Rs. 500/- (Rupees Five Hundred only) should be  
deposited with the tender in the name of "**Principal District &  
Sessions Judge, Aurangabad**" should ~~be~~ <sup>to</sup> deposited at the  
Assistant Supderintendent, Account & Finance Section, District  
Court, Aurangabad before submission of tender. Apart from that no  
tender will be considered. The said amount will be non-refundable.
- 03) Receipt of deposit of Rs. 500/- should be submitted to the Central  
Record Section, Dist. & Sessions Court, Aurangabad along with the  
sealed envelope containing the Tender.
- 04) Only those buyers whose prices are higher than the fixed price will  
be considered and scrapped documents will be sold to them.
- 05) It should be noted that, if those whose tenders are approved but do  
not purchase scrap within the prescribed period, then those whose  
scrap purchase rate is higher and suitable will be invited to purchase  
scrap.

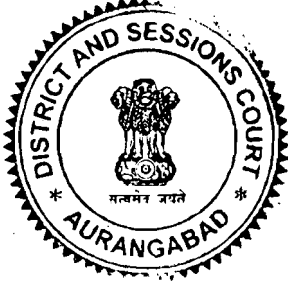

- 06) Those whose tenders will be approved should arrange weigh forks for measuring paper waste and sacks to fill all the waste.
- 07) Those whose tender will be approved should arrange to take the said scrap within 08 days. There will be no extension for this.
- 08) Scrap buyers should attach tender copy of the rate at which they have previously purchased scrap from the Government office for verification.
- 09) The right to disapprove the tender without assigning any reason as well as the right to cancel the notice of said tender at any stage will the Principal District and Sessions Judge, Aurangabad.

This tender notice should be published as per rules.
