I am directed to refer you on the subject cited above and to inform that at present in Punjab and Haryana local websites <a href="http://punjabjudiciary.gov.in">http://punjabjudiciary.gov.in</a> and <a href="http://haryanajudiciary.gov.in">http://haryanajudiciary.gov.in</a> respectively alongwith national website <a href="http://www.ecourts.gov.in">www.ecourts.gov.in</a> are being-maintained.

Hon'ble the Executive Committee of this Court in its meeting dated 07.08.2014 has decided not to maintain the local websites <a href="http://puniabjudiciary.gov.in">http://puniabjudiciary.gov.in</a> and <a href="http://haryanajudiciary.gov.in">http://haryanajudiciary.gov.in</a> except its cause list feature. It has further been decided that now onwards all the District Court Webpages on the National Website <a href="www.ecourts.gov.in">www.ecourts.gov.in</a> shall be duly maintained by all the District Courts by uploading complete information in accordance with enclosed document titled <a href="www.ecourts.gov.in">"WIFORM OUTLOOK OF THE DISTRICT COURT WEBPAGES ON ECOURTS GOV.IN"</a>

It is further decided that local websites <a href="http://punjabjudiciary.gov.in">http://punjabjudiciary.gov.in</a> and <a href="http://haryanajudiciary.gov.in">http://haryanajudiciary.gov.in</a> shall however be retained in order to redirect the user to the webpage of the respective Sessions Division on National Website <a href="http://www.ecourts.gov.in">www.ecourts.gov.in</a>.

- The list of Judicial Officers shall be prepared in accordance with the sample indicated in at **Annexure-A.**

#### c. Former Officers

- Names of all the District and Sessions Judge alongwith their period of posting since the creation of such Court in the respective Sessions Division or Sub Divisions.
- Names of all the Civil Judge (Senior Division) alongwith their period of posting since the creation of such Court in the respective Sessions Division or Sub Divisions.
- Names of all the Chief Magistrates alongwith their period of posting since the creation of such Court in the respective Sessions Division or Sub Divisions.

- Names of all the Presiding Officers, Industrial and Labour Tribunal alongwith their period of posting since the creation of such Court in the respective Sessions Division or Sub Divisions.
- Names of all the District Judge, Family Court alongwith their period of posting since the creation of such Court in the respective Division or Sub Divisions.
- Names of all the Presiding Officer, Special Environment Court alongwith their period of posting since the creation of such Court in the respective Sessions Division or Sub Divisions.
- Names of all the Special Judges, CBI Court alongwith their period of posting since the creation of such Court in the respective Sessions Division or Sub Divisions.
- Names of all the Special Judicial Magistrate, CBI Court alongwith their period of posting since the creation of such Court in the respective Sessions Division or Sub Divisions.
- For other designations which are more than one in number, it will be quite difficult to
  collate the date of all such officers who remained on such posts in all the Districts
  and, therefore, it is proposed that under this tab, the Judicial Officers who remained
  posted as Additional District and Sessions Judges or Civil Judge (Junior Division) in
  any Sessions or Sub Division shall be incorporated in w.e.f. 01-01-2014.
- The list of Judicial Officer shall be prepared designation wise. The list of Judicial
  Officers shall be prepared in accordance with the sample indicated in at <u>Annexure-B.</u>

#### d. Calendar

• Calendar for the District Courts of Punjab/ Haryana be displayed as approved by the Hon'ble High Court for the current year and two preceding years.

## e. Contact us

- Superintendents of each district shall be the contact person for any
  complaints/suggestions regarding updation or in respect of contents of web page. In
  this regard, Name, Designation and official email ID of the concerned Superintendent
  be displayed.
- However, the e-mails received on such e-mail ID shall be forwarded to the Ld.
   District & Sessions Judge and also to the Registrar (Computerization) of this Court to ensure quick follow up.

## 2. Cause List (local)

- Cause list of all the Courts as mentioned against the tab Judicial Officers, shall be uploaded on website after generation from C.I.S.
- Scanned PDF files of cause lists should be uploaded qua those courts which are not on C.I.S.
- Cause List shall contain name of the Officer, designation, place of posting, date of cause list, Court Room no., location of Court in the header.
- ullet The cause lists shall be uploaded latest by 4.00 P.M. on the preceding day.
- It shall be duty of the System Officer and System Assistants to ensure uploading of cause lists of all the Judicial Officers on the website under provision of Court Manager.

### 3. Judges on leave

- Information regarding leaves of Judicial Officers should be displayed in chronological order.
- Information about every leave shall be kept on website for a maximum period of one month from the date joining of the Judicial Officer availing such leave.
- Superintendent shall ensure to display this information on website as and when such leave applications are received and allowed.
- Complete spell sought to be availed by the Judicial Officer during the leave period shall be displayed on the website.
- The information shall be displayed in the format mentioned in at <u>Annexure C.</u>

• The information shall be displayed in the format mentioned in at  $\underline{Annexure - D}$ .

chargeable by the Court can also be uploaded under this head after approval from the
learned District and Sessions Judge.

- Description about the methodology of availing this facility.
- Name, Designation, any Contact nos. of the concerned Officers and officials.
- Link to the website of the State Legal Services Authority for more details.

## 9. Statutes and Rules

Link to India Code website for all Bare Acts, ADR rules, Gender Sensitization Rules, any
other item as directed by this Court or by learned District & Sessions Judge..

## 10. Right to Information

- Right to Information Laws/Rules
- Details of authorities designated under the rules/law
- Brief description of procedure for seeking information
- Consolidated statements of Institution, disposal and pendency of cases in Sessions Courts in the District/Sub-Division.

#### 11. Circulars / Notices

Also information regarding services available at District Courts for litigants and advocates can also be mentioned under this head.
