The following is the Educational qualification preferred for deployment of **Data Entry Operator:**

Qualification: SSLC/Diploma/PUC + Computer Certificate Course, Job typing certification.

Pay: Rs. 15,000/- (Take home to the candidate after statutory deduction i.e, PF, ESI etc would be Rs. 9,153/- only per month)


Age Limit: Minimum age 18 years.

Mode of Selection:

Selection of the candidates for submitting resumes to the Hon'ble High Court at the ratio 1:3 will be made on the basis of performance of the candidates in the interview to be conducted by the undersigned.
