GENERAL TERMS AND CONDITIONS:

- (1) The Bidders may contact the following persons of the District Court for any enquiry relating to the tender, on any working day between 11.00 a.m. to 4.00 p.m. -
- i. Ajay Singh, SO, Computer Center, District Court, Kanpur Nagar
- ii. Amit Kumar Gupta, DSA, Computer Center, District Court, Kanpur Nagar.
- (2) The Bidder should either be a Company registered/ incorporated under the Companies Act or a Firm registered under the Indian Partnership Act, 1932 or under the Limited Liability Partnership Act or Proprietorship firm registered under GSTN.
- (3) The Bidder is required to have adequate experience in supply, installation, testing, commissioning etc. of Servers, Unified Storage/ Backup Solution and must have experience/ expertise establishing Disaster Recovery sites. Bidder shall submit proof in support thereof.
- (4) Bidding by more than one company which joins with other companies of complementing skills to undertake the scope of work defined in this tender is not permissible.
- (5) The warranty period shall start from the date of successful installation, testing, commissioning, successful operation of all the items and handover of it taken by the BUYER.
- (6) Purchase Order shall be issued only after evaluation of the Technical and Financial Bid.
- (7) The SELLER is required to comply with the requirements of all the Relevant Applicable Acts. Rules and Regulations framed by the State Government/ Central Government relating to the contract work and the BUYER will not be responsible for any breach thereof.
- (8) It will be the responsibility of the SELLER to ensure that the work is completed in all aspects within the stipulated period of time as indicated in the tender document.
- (9) The BUYER reserves the right to cancel the contract at any time without assigning any reason and the decision of the BUYER will be final and binding on the SELLER.

In that event, the BUYER shall not be liable to pay any compensation to the SELLER. In case of any dispute, the Courts at Kanpur Nagar alone will have the exclusive territorial and subject matter jurisdiction.

- (10) On cancellation of the contract it will be open to the BUYER to award the contract to another party and the extra cost incurred by the BUYER in the completion of the work, loss/damages will be recovered from the SELLER.
- (11) If AMC contract is signed with the SELLER, then the SELLER will be responsible for maintenance of complete items (including third party items) supplied by the SELLER and services etc. on mutually agreed terms.
- (12) It is compulsory for the Bidder to Bid for entire solution as required in the tender.
- (13) The Bidder shall bear all the costs associated with the preparation and submission of his Bid.
- (14) Canvassing in any form in connection with the tender is strictly prohibited and will disqualify the Bidder.
- (15) The Bids of Bidders blacklisted by the Central Government/ State Government or instrumentalities thereof shall not be considered. The Bids of the Bidders/ their Partners/ Directors/ Agents against whom any criminal case is pending before any Court shall also not be considered.
- (16) The Bidders Shall duly submit the following documents/ certificate hereinafter mentioned: -
- i Authorization of the signatory of the Bid by the competent authority of the Bidder, to participate in this Bid;
- ii. Affidavit stating that the Bidder is neither blacklisted by the Central Government/ State Government or instrumentalities thereof nor any criminal case against the Bidder/ its Partners/Directors/ Agents/Proprietorship firm is pending before any Court;
- iii. Any other document(s)/certificate(s) required to be submitted as per the tender document.
- Bid(s) not conforming to any or all the above terms and conditions will be rejected.
- (17) The BUYER, in its discretion, reserves the right to reject all or any of the Bids without assigning any reason.
- (18) If due to administrative reasons, the venue for opening of Bids is changed, it will be conveyed to the Bidder.

BID PRICES

- (1) The Bidder shall give the total composite price inclusive of all kinds of Taxes viz. GST, packing, forwarding, freight and insurance etc. The basic unit price and all other components of the price need to be individually indicated against the items and services it proposes to supply under the contract. The offer shall be in Indian Rupees only. The price comparison shall be based on total prices of items.
- (2) The Basic Unit Price quoted by the Bidder shall remain fixed during the entire period of the Bid. A Bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.
- (3) Discount, if any, offered by the Bidder shall not be considered unless specifically indicated in the price schedule.

BIDDING AND SELECTION PROCESS:

- (1) Selection of the successful Bidder will be in two stage evaluation process:
 - (a) Financial and; (b) Technical
- (2) Technical evaluation will be performed on the basis of information provided by the Bidder in TECHNICAL BID PROFORMA of the tender document.
- (3) Technical Bids of only such Bidders who qualify the Lowest 5(Five) Financial Bid will be considered.
- (4) In case, tax(es) viz. GST are reduced subsequently by the Government at the time of placement of the Purchase Order or delivery, then the same will be adjusted by the SELLER.
- (5) It is unequivocally stated that the BID shall be disqualified: -
- i. If the Bids are not submitted in accordance with the prescribed conditions;
- ii. If a conditional Bid is submitted by the Bidder;
- iii. If the Bidder deviates from what offered in the Technical Bid and/ or in the Financial Bid.
- iv. If the Bidders form a cartel. In such a situation, they would disqualify themselves from participation in any Bid invited by the District Court for three years.

AWARD OF CONTRACT:

The BUYER may award the contract to the Bidder whose Bid is found to be most responsive, competitive and technically sound. The decision of the BUYER in this regard shall be final and binding on the Bidder(s). The BUYER, however, in its discretion, reserves the right to reject all or any of the Bids without assigning any reason.

SIGNING OF CONTRACT:

(1) The issue of Purchase Order shall constitute the award of contract on the successful Bidder.

LIQUIDATED DAMAGES:

1) The BUYER reserves the right to reject any items supplied against the Purchase Order, if found not working satisfactorily at the time of installation at site(s). The rejected items, if any, shall have to be taken back and replaced by good quality items forthwith at the cost of the SELLER. No payment will be made for the rejected item(s).

TITLE, RISK AND INSURANCE:

- (1) Title of ownership of the items shall pass onto the BUYER from the date and time of handover. All risks of losses and/ or damages shall be borne by the SELLER till the title passes to the BUYER.
- (2) The SELLER shall be responsible for supply, installation, testing and commissioning of all the items at the District Court. All the risks of losses and/or damages shall be borne by the SELLER during supply, installation, testing and commissioning of all the items.
- (3) If upon installation of items they are found to be defective, then the SELLER shall replace the same by new ones. Any expenditure incurred in replacement of the defective items shall be borne by the SELLER.

MAINTENANCE:

(1) The SELLER shall provide free maintenance services of the items supplied and installed by the SELLER from the date of acceptance, during the onsite comprehensive warranty support of 3 years on all working days or on urgent basis on Site of Installation.

TERMS OF PAYMENT:

The payment for the items supplied by the SELLER shall be made by the BUYER as follows:-

- (1) Payment shall be released on the basis of the stages of completion of work.
- (2) 20% shall be released at the time of issuing of Purchase Order and thereafter each completed stage installment of 20% shall be released.
- (3) Any decrease in rate of tax viz. GST at the time of delivery of the items to the District Court then the same will be adjusted by the SELLER.
- (4) The SELLER will pay all the applicable taxes.
- (5) Payments under the contract will be made in Indian currency only.
