The eligible candidate shall be engaged initially for a period of 11 months which may be extended time to time. The selection will be made after conducting written examination of multiple choice question judging the basic understanding of the concerned candidate. The examination will be conducted in the vernacular language and shall comprise of 40 (Forty) marks. This would be followed by suitability test to be judged through oral interaction, which will carry 10(ten) marks. There will be no failing marks in either of the two tests.
