MEMORANDUM.

In compliance to order of the Hon' ble High Court of Tripura vide No.F.44(1)(c)-HC/2022/1093 dated 11.01.2022 and in order to contain the spread of Covid-19 in the Agartala Court Complex, a meeting was held under the Chairmanship of the undersigned with the following officials :

- b) Chief Judicial Magistrate-cum-Civil Judge(Sr.Divn), West Tripura, Agartala;
- c) The President, Tripura Bar Association, Agartala;

- e) Officer In Charge, West Agartala Police Station;
- f) Court Sub-Inspector, Sadar Police Court, Agartala;
- g) The President and Secretary, Agartala Law Clerks Association

After discussion, to ensure protective measure in the Court complex, **following decisions have been taken:**

- 1) Wearing of mask by the staff members, Advocates and litigants in the Court premises is compulsory.
- 2) Social distancing should be maintained not only in the Court premises but also in the Court Halls /rooms/sections.
- 3) The Ld. Advocates of the Bar shall ensure that the litigants and visitors whose presence is not necessary in the Court, may not visit the court premises.
- 4) Entry of litigants and public will be restricted in the premises.
- 5) Main gate of West side of the Family Court building will be closed at 10.45AM till 5.00PM on all working days.
- 6) In the gate near Court Sub-Post Office, the Entry of litigants and visitors will be allowed only on production of Identity card, Court notice, Summons etc.
- 6) The Entry through the gate in the eastern side of the Court complex of Chief Judicial Magistrate, West Tripura, Agartala will be restricted. The Entry of litigants and visitors will be allowed only on production of Identity card, Court notice, Summons etc.

- 7) The Court Sub-Inspector, Sadar Police Court, Agartala shall depute one staff from Police Court alongwith 02 TSR personal in all the aforesaid entry gates for checking.
- 8) The Office In Charge, West Agartala Police Station shall depute sufficient TSR personal in the court premises for performing duty.

These precautionary measures will take immediate effect until further order.
