**AUCTION NOTICE**

Sealed tenders in plain paper from the bonafide buyers are invited for sale of one old **Ambassador** vehicle bearing No. **TR-01-F-0971**, Engine No. **3ELEM114251**, Chassis No- **MA7AM18MFMU017924** of the Office of the Judge, Family Court, Agartala, West Tripura, purchased on **08/04/2013**. This said vehicle has been declared “**CONDEMNED**” by Law Department, Government of Tripura vide Notification No.F.1(4)-Law/Estt.1/2018/8267-73 dated 5<sup>th</sup> July, 2023. The terms and conditions in respect of the Auction shall be as follows:-

1. The vehicle for which tender is invited for sale will be available for inspection in presence of the Nazir of the establishment of the Judge, Family Court, Agartala, West Tripura w.e.f **17/08/2023 to 29/08/2023** during Office hours.
2. Tender in sealed cover is to be deposited to the Office of the Judge, Family Court, Agartala w.e.f **17/08/2023** and must reach by **01:00 pm** on **29/08/2023**.
3. The reserve value of the vehicle as assessed by the Executive Engineer, PWD, Mechanical Division, Agartala and approved by Law Department, Govt. of Tripura is fixed at **Rs.17,500/- (Rupees seventeen thousand five hundred) only** and no tender below the said value will be accepted.
4. The sealed tender will be opened on **29/08/2023 at 04:00 pm** in the presence of the Auction Committee, Family Court, Agartala, West Tripura and tenderers may remain present if they so desire.
5. Tenders received after scheduled date and time will stand rejected.
6. The Auction Committee, Family Court, Agartala, West Tripura reserves the right to accept or reject any tender without assigning any reason thereof.
7. The successful tenderer will be required to make full payment of the offered price within **7(seven) days** from the date of intimation about the acceptance of the tender, failing which the offer of acceptance will be cancelled and the subsequent highest tenderer shall be called upon and so on.
