STEP I	Open Web-browser of your mobile phone (google chrome, or safari or opera.etc.) and Open the website of this Sessions Division i.e. http://districts.ecourts.gov.in/faridabad and then Click on the tab “Video Conferencing Link” under “Magistrate > Duty Magistrate” tab Or “Quick link” tab.
